Which constitute the "Licence /Contract holder", which expression shall unless it is repugnant to the context or meaning thereof shall deem to mean and include its successors and assigns of the **ONE PART.**

AND

The Principal, N.I.T.K. ENGLISH MEDIUM SCHOOL, hereafter referred to as "N.I.T.K.-EMS", which expression shall unless it be repugnant to the context or meaning thereof shall deem to mean and include its successors and assigns of the **OTHER PART. NOW, THEREFORE**, IT IS HEREBY AGREED between the Parties as follows:

SCOPE OF WORK.

- 1) N.I.T.K. English Medium School intends to procure NCERT Text Books, Private Publisher's Text books and Customised Note Books with Labels in English for the Academic Year 2023-24 from the successful bidder and promote the establishing a Tuck Shop in the premises of the NITK English Medium Scholl for the direct supply to the students the required NCERT Textbooks, Private publisher's text book, customized note books with labels in English for the academic year 2023-24 for the facility to the students in the school premises.
- 2) NCERT Text Books, Private Publisher's Text books and Customised Note Books with Labels in English (ANNEXURE) are required to be supplied and distributed well in time to the students before the commencement of the academic year.
- 3) The NCERT Text Books, Private Publisher's Text books are to be supplied by the successful bidder as mentioned in the annexure.
- 4) The NCERT Text Books, Private Publisher's Text books and Customised Note Books with Labels in English shall be as per the requirements and instructions of the Principal with supply and distribution in three phases in 15 days,.
 - i. Phase 1 : On or before 10 March 2023 for Classes IX & X.
 - ii. Phase 2: 2nd week of April 2023 for L.K.G to VIII
 - iii. Phase 3: Last week of May 2023

Article1: Effective Date

Article 1A: General Provisions

DEFINITIONS & INTERPRETATIONS

- a) "Licence/contract" shall mean this Agreement and all Schedules, supplements, appendices, appendages and modifications thereof made in accordance with the terms of this Agreement.
- b) "Successful bidder" means eligible agency/company/firm/dealer operating inside the N.I.T.K. ENGLISH MEDIUM SCHOOL, which is authorized by N.I.T.K. ENGLISH MEDIUM SCHOOL under this agreement on contract/licence basis and where the NCERT Text books are stocked and distributed to the students of N.I.T.K. ENGLISH MEDIUM SCHOOL
- c) "Licence/Contract holder" means the successful bidder recognized by N.I.T.K. ENGLISH MEDIUM SCHOOL to establish the tuck shop.
- d) "Deployed persons" means the manpower provided by the Licence/Contract holder.
- e) "Tuck shop" means a temporary shop of the successful bidder's agency/company/firm, established at N.I.T.K. ENGLISH MEDIUM SCHOOL.
- f) "Counter sale" means sale of NCERT Text books, Private Text books, Customised Note books with Labels at the Tuck Shop.
- g) "School" means N.I.T.K. ENGLISH MEDIUM SCHOOL(N.I.T.K.-EMS) and shall deem to mean and include its successors and assignees.
- h) "NCERT" means The National Council of Educational Research and Training (NCERT), an autonomous organisation set up in 1961 by the Government of India.
- i) "NCERT Text Books" means Text books prescribed by NCERT for academic curriculum of the school.
- i) "Beneficiaries" means the N.I.T.K. ENGLISH MEDIUM SCHOOL Students
- k) "Principal" means head of the School
- 1) "Quoted Rate" means the rates quoted agreed by the Licence/Contract holder.
- m) "Party" shall mean either the Institute or the Licence/Contract holder and "Parties" shall mean both the School and the Licence/Contract holder.
- n) "President" mean the head of the School Management Committee /Trust..
- o) "Secretary" means the Secretary of N.I.T.K. ENGLISH MEDIUM SCHOOL.

<u>Article 2: Stock and Distribution of NCERT Textbooks, Private Text books, Customised Note books</u> with labels

The Licence / Contract warrants that he/she has all the required facilities / licences / certificates etc.,for undertaking the Procurement of NCERT Text books and facilitating Tuck Shop counter sale in the school premises at N.I.T.K. ENGLISH MEDIUM SCHOOL.

- a. The Licence / Contract Holder shall stock NCERT Text books as required at the established Tuck shop and distribute by counter sale the same to the Beneficiaries as per the requirements of N.I.T.K. ENGLISH MEDIUM SCHOOL.
- b. The Tuck shop will function during the working hours/days as that of the N.I.T.K. ENGLISH MEDIUM SCHOOL's

working hours/days and as per the requirements of N.I.T.K. ENGLISH MEDIUM SCHOOL

The Licence / Contract holder shall have his own qualified, well mannered, experienced staff at the Tuck shop.

The payment of salary, EPF, ESI, bonus etc., to the deployed persons is to be borne by the Licence/Contract holder.

The Licence / Contract holder would utilize the Outlet provided in the N.I.T.K. ENGLISH MEDIUM SCHOOL for establishing the Tuck shop and take full responsibility of the same during its activities.

It is the sole responsibility of the Licence/Contract holder to maintain the structure of the Tuck shop outlet in the N.I.T.K.ENGLISH MEDIUM SCHOOL and any alteration or modification (Civil / Electrical), if necessary, is to get the prior approval of the Principal ,N.I.T.K. ENGLISH MEDIUM SCHOOL.

The Licence/Contract Holder agrees to offer % Discount on MRP of NCERT Text books and the total contract

value is The same should be offered to the students without adding any extra charges like GST, transport charges, package charges etc. The discount offered shall be valid throughout the period of contract.

The Licence/Contract holder agrees to undertake the scope of work at the quoted rates for the entire duration of the contract/extension of contract.

The Possession of the Premises (Tuck shop Outlet) granted to the Licence/contract Holder shall continue with the N.I.T.K ENGLISH MEDIUM SCHOOL and the Licence/Contract shall be given only to stock NCERT Text books and distribute by counter sale the same to the Beneficiaries

Article 3: Quality of Services.

The Licence/Contract holder will treat the Beneficiaries in a courteous manner and according to good social practices.

The Licence/Contract Holder shall follow the standard procedures for Stocking/supply and distribution of the NCERT, Private Text books and customized notes books with labels, and as directed by the Principal, N.I.T.K. ENGLISH MEDIUM SCHOOL.

The Licence / Contract holder shall follow the Covid-19 protocols laid by the Govt. of India and Govt. of Karnataka.

Article 4: Payment Terms and conditions / Billing

The amount of Performance Security shall be liable to be forfeited, if the NCERT Text books are not as per the indent of the Principal ,N.I.T.K ENGLISH MEDIUM SCHOOL or not conforming to quality, quality or syllabus.

The Performance Security is also liable to be forfeited if the Successful bidder:

- 1. Fails to adhere to the terms and conditions of the contract.
- 2. Stocks/Distribute any sub-standard, pirated/fake / duplicate NCERT Text books.
- 3. Delayed supplies.
- 4. Over Charges.

The Licence/Contract Holder shall issue Tax invoices /bills as per the Government Specifications to the Students of the N.I.T.K. ENGLISH MEDIUM SCHOOL. The bills shall contain: the name of NCERT Text Book, Quantity, Rate, GST (if any), Discount offered and total amount. The total amount shall not cross beyond the amount calculated, after applying the quoted discount on MRP of the Text books.

The Licence/Contract Holder shall collect the payment of purchases through cash / PoS machines (Card Swipe machine) at the Tuck Shop.

Article 5: Limitations of liability and indemnity

The Licence/Contract holder is responsible for all commissions and omissions in executing its scope of work and will also be responsible for all legal consequences that may arise, The N.I.T.K ENGLISH MEDIUM SCHOOL/the principal/the secretary or any authority of the school will not be held responsible for the outcome and should any legal complications arise and is called upon to answer, the Licence/Contract holder should defend the same at their cost.

The Licence/Contract holder admits and agrees that if any claim arises out of alleged deficiency in its activities/service on their part or on the part of their deployed persons or agents, then it will be the duty of the Licence/Contract holder to answer such claim. In the unlikely event of the N.I.T.K. ENGLISH MEDIUM SCHOOL/the principal/the secretary or any authority of the school being proceeded against for such cause of action and any liability was imposed

on them, only by virtue of its relationship with the Licence/Contract holder, and then the Licence/Contract holder will step in and meet such liability on their own. Notwithstanding anything to the contrary in this Agreement, neither Party will be liable by reason of failure or delay in the performance of its duties and obligations under this Agreement if such failure or delay is caused by:, acts of Nature (Natural disaster), accidents, Strikes, lock-outs, embargoes, war, riots civil commotion, any orders of Governmental, Quasi-Governmental or local authorities, or any other similar cause beyond its control and without its fault or negligence.

Article 6: Confidentiality

6.1 The Licence/Contract holder undertake to protect the secrecy of all the data of Beneficiaries and this office and trade or business secrets of and will not share the same with any unauthorized person for any reason whatsoever within or without any consideration.

Article 7: Termination

7.1 Any deficiency in service by the Licence/Contract holder will be looked into by the technical committee of the N.I.T.K. ENGLISH MEDIUM SCHOOL and if anything is found wanting, such successful bidders will be de-listed and the decision of the committee will be final.

Article 8: DUTIES AND RESPONSIBILITIES OF LICNCE/CONTRACT HOLDER

It shall be the duty and responsibility of the Licence/Contract holder, at all times, to obtain, maintain and sustain the valid recognition and high quality and standard of its activities/services and to have all statutory / mandatory licenses/registrations/Certificates, permits or approvals of the concerned authorities under or as per the existing laws.

Article 9: ARBITRATION

If any dispute or difference of any kind whatsoever (the decision whereof is not herein otherwise provided for) shall arise between the Institute and Licence/Contract holder upon or in relation to or in connection with or arising out of the Agreement, shall be referred to for arbitration to the Arbitrator. The Arbitrator's award is the final and Conclusive.

The Arbitrator would be the President of the N.I.T.K. ENGLISH MEDIUM SCHOOL

Article 10: Miscellaneous

Authorized signatory / representative of the Licence/Contract holder shall attend the periodic meetings held by the Principal / Establishment of the School, required in connection with improvement of working conditions.

The Licence / Contract holder shall not make any commercial publicity projecting the name of the School.

Nothing under this Agreement shall be construed as establishing or creating between the Parties any relationship of Master and Servant or Principal and Agent between the N.I.T.K ENGLISH MEDIUM SCHOOL and the Licence/Contract holder.

The Licence/Contract holder shall not represent or hold itself out as agent of the School.

The Licence/Contract holder shall notify the School of any material change in their status and their shareholdings or that of any Guarantor of the Licence/Contract holder in particular where such change would have an impact on the performance of obligation under this Agreement.

Should the Licence/Contract holder get wound up or partnership is dissolved, the School shall have the right to terminate the Agreement. The termination of Agreement shall not relieve the Licence/Contract holder or their heirs and legal representatives from the liability in respect of the services provided by the Licence/Contract holder during the period when the Agreement was in force.

The Licence/Contract holder shall have its own approved PoS machines, network connectivity (Wi-Fi), letter pad, rubber stamp seal, stationeries etc.
